ACCEPTANCE AND DECLINE OF CAR ENTRIES: Acceptance is at the discretion of the Organiser. Car entries will only be considered if all criteria are met and your application is completed in full. This includes; agreeing and accepting ALL Summernats Terms and Conditions of Entry, full payment received, recent photograph/s of your vehicle provided and the Entrant's Declaration is completed as part of the entry process. The final decision of vehicle entry acceptance will be made at scrutineering and the Organiser reserves the right to decline any entry without

necessarily assigning a reason. Should this occur, a full refund of any monies paid will be returned. Upon receiving your application and an acceptance of approval, an email notice will be forwarded to your registered email address.

AMBUSH MARKETING: Vehicles displaying excessive sponsor branding, advertising or marking material may not be permitted to enter Summernats without prior arranged permission. The 'Sticker Guide' on the car entry application outlines what is acceptable.

VEHICLE DISPLAY LIMITATIONS: Entrants cannot use their vehicle display as a trade display. Information on the vehicle's build and relevant suppliers are acceptable but no commercial handouts or display material will be allowed. VEHICLE CHANGES: Change of vehicles are permitted provided the new vehicle meets the minimum requirements as outlined in the 'Vehicle Entry Guide' and can be made by calling the Summernats Office prior to online entry closure in December or upon arrival at scrutineering. Any changes made at scrutineering may cause delays with processing your vehicle entry.

CHANGE OF ENTRANT/DRIVER: Car Entries cannot be transferred, sold or given to another individual for the purpose of use as a participating entrant. Credit transfers to the next event are available and will be subject to an administration fee of 10% from the total ticket amount only and are to be requested in writing prior to 1 December. Full details and conditions of the credit transfer will be forwarded to you via your registered email address after the event you are transferring from. Any unused credit amount not claimed before the 1 December of each transferred year will incur a further 10% administration fee per year until all credit amounts are used.



ALCOHOL: Entrants driving motor vehicles within the grounds are subject to the same limits and laws as per their current driving licence. Full licence holders - limit of under 0.05 alcohol content. Special, probationary, international, provisional licence holders – limit of zero alcohol content (0.00)

Summernats has a zero alcohol limit for Entrants wishing to compete in any driving event at the Summernats. Breath testing is conducted at the event. If you refuse to submit to a breath test you will not be permitted to compete and may be removed from the event.

LICENCE REQUIREMENTS: ALL Summernats entrants must hold a current, un-restricted, unsuspended drivers licence. Learner drivers are not permitted. Drivers with provisional licences are permitted to enter a car however restrictions applied to the licence conditions in the state of issue apply at all times.

PROHIBITED ITEMS: ALL Entrants must submit to a search of any car, trailer or transporter each time their vehicles enter Exhibition Park.

No Alcohol or Illicit drugs are to be brought into Exhibition Park during the Summernats. You are NOT permitted to bring fuel to Summernats. No Storage facilities will be available. Refuelling is NOT permitted in all car parks and grounds as well as the entire Exhibition Park precinct. Any alcohol, fuel or other prohibited items found will be confiscated and not returned.

Other prohibited items include – Motorcycles, glass drink containers of any type, animals, fireworks, weapons, pools and spas, Drones, Motorised scooters, eskies, skateboards or any other unauthorised vehicles.

CONDUCT: Entrants must conduct themselves in a civil and well-behaved fashion and are responsible for their buddies' behaviour. Unacceptable behaviour will result in ejection from Exhibition Park, cancellation of all Summernats entitlements including any awards and prize money and may affect your future at Summernats. No Refunds will be given.
